MCM Scholarship Type – 1 (10 students)

- The scholarship is of Rs. 1000/- per month and the recipients would be exempted from paying the tuition fees only.
- All India JEE Mains Rank of joining year will be used for first year scholarship however for second year onwards, it will be based on the merit of previous year.
- Not getting any assistantship/scholarship/ fellowship from any other sources.
- Parent's /guardians total gross annual income from all sources is Rs. 6.00 Lakhs or less.
- Students must have the academic standard of minimum 7.00 CGPA or more on a 10-point scale and should not have any active backlog.

- The scholarship is of Rs. 36000/- per annum.
- All India JEE Mains Rank of joining year will be used for first year scholarship however for second year onwards, it will be based on the merit of previous year.
- Students must have the academic standard of minimum 7.00 CGPA in subsequent semesters and should not have any active backlog.
- Parent's /guardians total gross annual income from all sources is Rs. 8.00 Lakhs or less.
- Not getting any assistantship/ scholarship/fellowship from any other sources.
